

FUND UPDATE

Maritime Retirement Scheme – Balanced Fund for the year ended 31 March 2021

This fund update was first made publicly available effective 30 June 2021.

WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the fund has performed and what fees were charged. The document will help you to compare the fund with other funds. The Trustees of the Maritime Retirement Scheme prepared this update in accordance with the Financial Markets Conduct Act 2013.

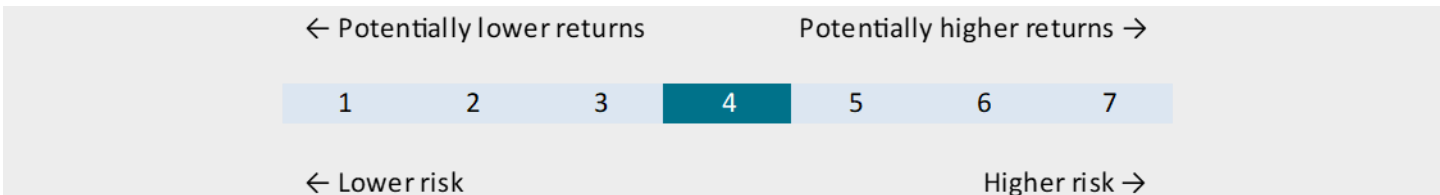
DESCRIPTION OF THIS FUND

Invests in a wide range of assets, about 60% comprising growth assets such as shares and 40% comprising income assets such as bonds and cash. Suited to longer-term investors who want a diversified portfolio of assets with a high exposure to shares and other growth assets and are willing to accept more ups and downs than can be expected from the Conservative Portfolio.

WHAT ARE THE RISKS OF INVESTING?

Risk indicator for the fund:



The risk indicator for the Balanced Fund is 4. The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

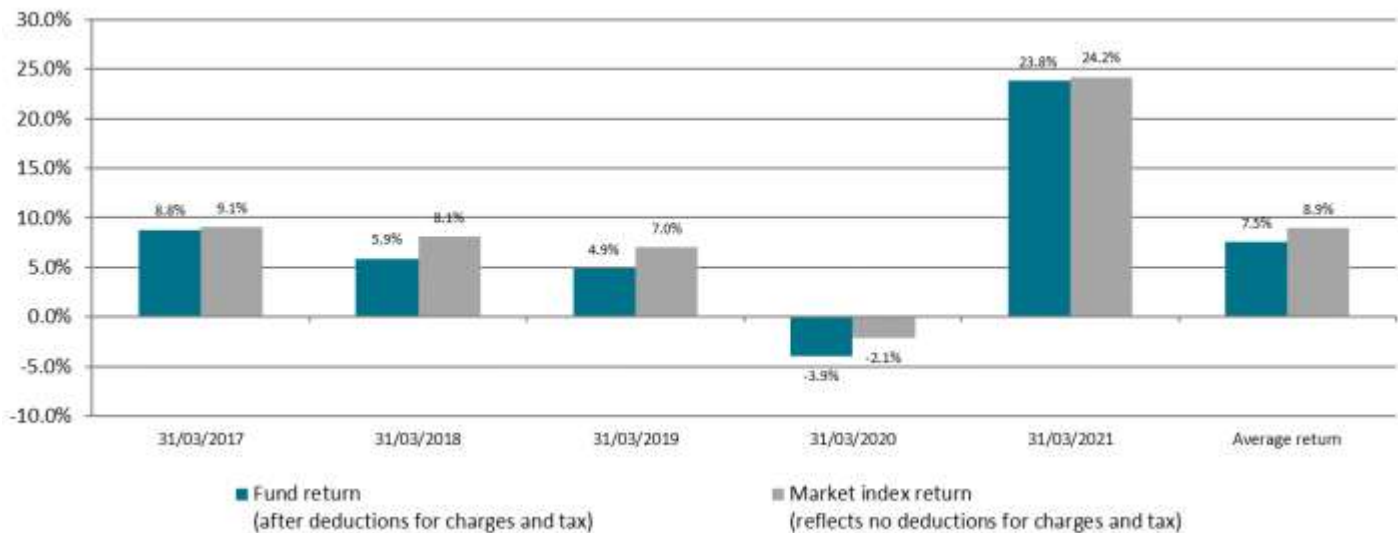

HOW HAS THE FUND PERFORMED?

ANNUAL RETURN GRAPH



This shows the return after fund charges and tax for each ending 31 March since the fund started. The last bar shows the average annual return since the fund started.

Important: This does not tell you how the fund will perform in the future.

The returns in this update are after tax at the highest prescribed investor rate (PIR) of tax for an individual New Zealand resident. Your tax may be lower.

The last 1-year period shows strong returns for many funds. This is because it excludes the February/March 2020 COVID-19 sell-off in the market but includes the subsequent recovery.

Small differences in fees and charges can have a big impact on your investment over the long term.

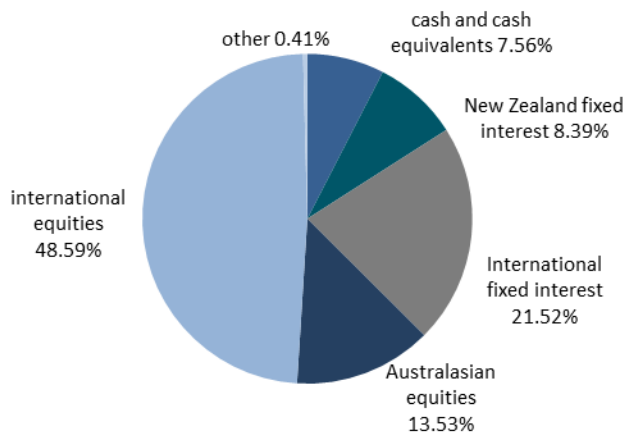
EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Brian had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Brian received a return after fund charges were deducted of \$2,382 (that is 23.82% of his initial \$10,000. No other charges were deducted. This gives Brian a total return after tax of \$2,382 for the year.

WHAT DOES THE FUND INVEST IN?

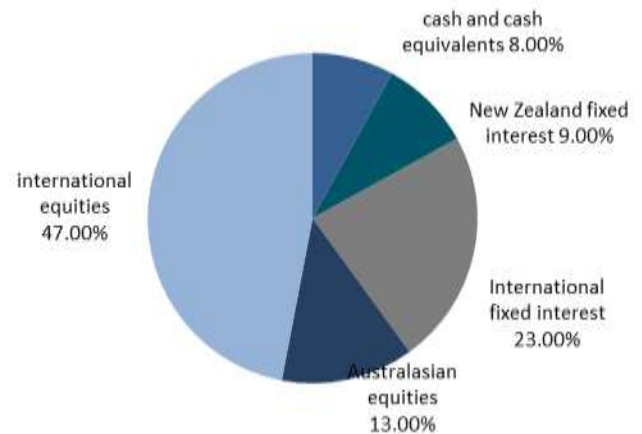
Actual investment mix
